## **PUBLIC NOTICE**

We recently became aware of a large number of trademark violations regarding the "**ZENIQ**" brand. The "ZENIQ" brand is subject to international trademark protection (see links below). All of the following trademarks are owned by <u>Geneirah Group Ltd.</u>, Burlington Tower 416, Business Bay, Dubai, United Arab Emirates, Reg.No. ICCRD20200040.

The following trademarks are registered with the **European Union** Intellectual Property Office (EUIPO):

- Word mark ZENIQ, registration number 018440321, classes: 9, 14, 36, 41, 42
- Word and design mark ZENIQ, registration number 018444844, classes: 14, 36, 41, 42

The following trademarks are registered with the **World Intellectual Property Organization** (WIPO) as **national** trademarks:

- Word mark ZENIQ, registration number 2253365, classes: 9, 14, 36, 41, 42 (Australia)
- Word mark ZENIQ, registration number 1204301, classes: 9, 14, 36, 41, 42 (New Zealand)

The following trademark is registered with the **World Intellectual Property Organization** (WIPO) as an **international** registration:

• <u>Word mark ZENIQ, registration number 1647629</u>, classes: 9, 14, 36, 41, 42 (Australia, Bahrain, Brazil, China, Canada, Colombia, Estonia, India, Israel, Japan, Mexico, New Zealand, Oman, Philippines, Russia, Switzerland, Turkey, USA, UK).

The above trademarks therefore enjoy **national and international protection** in the European Union and in **numerous** other **countries**. Use of the above brands is therefore only permitted on the basis of a license granted by Geneirah Group Ltd. Such a license has so far **only been granted** to the following companies:

- ✓ **ZENIQ Technologies Ltd.** with the <u>Reg.No. 4742 in DIFC</u>, Dubai as well as
- ✓ Safir Global DMCC with Reg.No. DMCC190386 in Fortune Tower, Dubai and
- ✓ Safir Global Ltd. with the Reg.No. 230989 granted in the Seychelles.

Contrary agreements or contracts not with Geneirah Group Ltd. have been completed are lapsed and ineffective with regard to the use of the trademarks. In particular, we point out that the following companies are definitely **NOT allowed** to use the mentioned ZENIQ trademarks:

- **Zeniq Corporation AG** with Reg.No. CH-170.3.047.639-6 in Switzerland,
- Zeniq DMCC, with Reg.No DMCC194996 in Dubai,
- Ramziq Technologies Ltd. with Reg.No. 5918 in DIFC, Dubai,
- Ramziq Holding SA with Reg.No. B 265.566 in Luxembourg AND
- Safir Group International Ltd. with the Reg.No. 234562 in the Seychelles.

We also point out that **Safir International Ltd.** in Ras Al Khaimah with Reg.No. ICC20180860 was already **liquidated** on March 14, 2022 and no use of the trademark was or is permitted.

Trademark violations through unauthorized use of the ZENIQ trademark, including but not limited to the **promotion and sale of ZENIQ branded products and services at events, zoom conferences or any other way** without a valid license agreement, will be promptly pursued by the sole global trademark owner, Geneirah Group Ltd.
